Advanced Group Crisis Intervention (AGCI)

This two day course is designed to cater for those providing group support services after crisis for at least two years and who have previously completed the Group Crisis Intervention (GCI) course (or equivalent).

- Planning for the pre-incident and post-incident responses
- Focused practice in complex scenarios around large and small group interventions including group psychological first aid
- Differentiating between trauma and crisis responses
- Community effects in the short and long term
- Advanced minimising risk and maximising benefits of group interventions, and
- Secondary traumatisation and protecting the helper long term.
